The same accounts for 38s 7d as arrears from the account of the preceding year.

Rent of Assize (Fixed Rents)

And for 6s 10½d as rent from the free tenants of the aforesaid lord this year, paid at the terms of Easter and Michaelmas, that is to say from John Norman, John Abell, Robert Partryche, Robert Mitton, Robert Warnere, John Bawed', John Mitton, Thomas Stoughton, Prior of Newnham and John Gostwyk the elder, as appears in detail in a certain rental newly renewed by the Steward and all the aforesaid lord's homage in the account examined in the 25th year of the late King Henry VIth. (1446), remaining in the archive of the said accountant in the bag of the court rolls of the aforesaid lords.

Rents in kind

And for 15d as the value of 2 (*or 6?*) capons rendered by tenants there this year as appears in the preceding account. And for 1 pound of pepper, rendered by Robert Warner following ancient custom, and nothing should be given to the lady this year because it is delivered to the lady's auditor on the account of their fee,.

Rents of half virgates

And for £22 13s 4d as rents from one¹ half virgates of land in Wyllington as charged in the preceding year

Sum £22 13s 4d

Rents of Acremen

And for 61s 4½d as rents of Acremen there as charged in the preceding year

Rents from the Demesne lands

And for £18 for the rents of the Demesne lands in Wyllington, so demised to the same tenants by the Steward this year, as appears in the court roll in the year of the reign of king Henry 6th ². £27 used to be paid, and lately £20.

Rent from the mill

And for 53s 4d rent of the water mill at Wyllington, so demised to John German for the term of 12 years by the Steward and Receiver, and the said John will repair the said mill and all parts of

the building (?) at his own cost and expense during the aforesaid term, as appears in the court toll of the 19th year of King Edward fourth (1479) this year the third year of his term, formerly at 73s 4d

Sum 53s 4d

Profits of the manor

And for 26s 8d from the rents of the several waters of Wyllington (13s 4d) and rabbit warren (13s 4d) and flying game within the demesne there, so demised this year to the said Accountant and the tenants there which was charged 40s from ancient time.

And from the pannage of pigs within Shirehatch and elsewhere within the demesne there, however from the aforesaid swans, the herons, pheasants, partridges and other flying game within the warren there this year not rendered because demised to the above with the rent of the rabbit warren. Nothing is rendered from the sale of wood, or underwood, sale of fallen or old hedges. Without honey combe or a swarm of bees there this year and that no profit is had within the same time falls due on the oath of the said Accountant so rendered.

And for 4s for the price of half an acre of underwood sold from one Grove there called Wyllington Grove by the said Accountant this year,

From the sale of underwood from a certain wood called Shirehache this year, nothing paid because nothing was had from the underwood being sold there, for the same time, the oath of the said Accountant.

Perquisites of court

And for 7s for paper and parchment for 1 Lete and 1 View of Court held there this year as appears in the rolls of them on the examination of the account

And for 21s 3d from Sheriffs Aid there from the view there this year, taken from the Tenants annually, following ancient custom

From feudal dues for ward, marriage, from the chattels of vagabonds and strays, from felons and fugitives, hunted at large and native born within the aforesaid demesne without excommunication, heriot, leywrite or from all causes within the demesne there fallind due there during the time of this account, nothing rendered because there have been no profits there falling within the same time, by the oath of the said Accountant

And in the reductions of rent for various lands and tenements in Wyllington as ordered above rendered of old. that is to say in Title, fixed rents, rents in kind, rents of half virgates of land, and rents of acremen and the hand of the Reeve, £19 0s 11d raised therefrom not put as appears prout particlr in certain paper rolls made by William Jordan there 16th January in the 17th year of King Henry VI penes ipium rem omnis Copia comp'' aforesaid is consul and ... in reductions this year £7 22d.

Allowances of money

And in allowance of money to John Sapcote esquire, the lady's Receiver there, for profits of his office this year at various times, that is to say, the first time on the third day of May in the said 21st year £4, second time in the 30th day of the same month the same year £8 by the bill allowed above on this account and the aforesaid Memorandum and paid, the third time in the month of October on the account £10 and for the fourth time after the claim for this account £7 14s without bills for them without being examined, by the Receiver to the detriment of his account, £29 14s

Sum of all the aforesaid allowances and payments of money £48 13s 9d and is owed 59s 11d. and from certain allowances 8s for ... payment from various rents of land there as from the total money granted for ploughbote this year from the agreement on the same made by statute.
